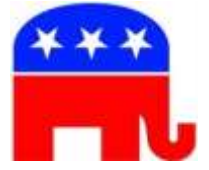

Pursuant to the Article VII of the Bylaws of the Adams County Republican Central Committee, and Colorado Revised Statute § 1-3-102 & 103, notice is hereby given that the **Adams County Republican Organizational Meeting** shall be convened beginning at 8:00 am on Saturday 02 February 2019 at

Check-in and credentialing for this ACRC Republican Organizational Meeting shall begin at 7:15 am. The principle purposes of this meeting will be:

General ACRC Session (Tentatively 8-10am)

- Prayer, Pledge, Credentials Report & Approval, Proposed Rules & Approval
- To close out current ACRC Administration with final updates.
- To elect one ACRC Chairman
- To elect one ACRC Vice-Chairman
- To elect one ACRC Secretary
- To select and designate appropriate vacancy committee, and vacancy committee chairman, for the ACRC.
- To select and designate appropriate vacancy committee, and vacancy committee chairman, for the office of County Commissioner.
- To conduct any other business that may properly come before it.

House District Session (Tentatively 10-11am)

- To elect fourteen (14)* Bonus Members to the CO GOP State Central Committee.
- To elect up to seven (7) ACRC District Captains per House District
- To elect one House District Chairman, one Vice Chairman, and one Secretary (for HD 30, 31, 32, 34, 35, and 56)**
- To elect HD vacancy committee(s) as applicable per HD bylaws.
- To conduct any other business that may properly come before it as applicable per HD bylaws.

Senate District Session (Tentatively 11am-12noon)

- To elect one Senate District Chairman, one Vice Chairman, and one Secretary (for each SD 21, 24, and 25)
- To elect SD vacancy committee(s) as applicable per SD bylaws.
- To conduct any other business that may properly come before it as applicable per SD bylaws.

Congressional District Session (Tentatively 12 noon-1pm)***

- To elect four (4) Bonus Members to the CD 6 Congressional District Central Committee.
- To elect ten (10) Bonus Members to the CD 7 Congressional District Central Committee.

** Current allocation of 2019-2020 bonus members will be HD 30 –2 Bonus Members, HD 31 -3 Bonus Members, HD 32 -1 Bonus Member, HD 34 -2 Bonus Members, HD 35 -3 Bonus Members, and HD 56 -3 Bonus Members. Additionally, those elected as Bonus Members to the CO GOP State Central Committee are also elected as Bonus Members to the 17th Judicial District Central Committee as per ACRC Bylaws Art. VI, Section 1D.*

***House District 56 is a multi-county district and will have their meeting at another date as per their official HD 56 call. The Adams County portion of HD 56 will still meet as mentioned above for activities to support their multi-county meeting.*

**** No bonus members were allotted to Adams County Republicans in CD 4 for the years 2019-2020.*
